Ementa

A disciplina propõe apresentar a “virada infraestrutural” dos estudos urbanos do início do século XXI. Se antes os espaços construídos já eram objetos importantes do campo, agora um conjunto de pesquisadores do Sul Global começou a analisar os problemas e as formas de produção e distribuição do acesso a infraestruturas urbanas. Ponto em questão o acesso à água, eletricidade, esgotamento sanitário e coleta de resíduos, entre outros, uma série de novas perguntas surgiram: quais são as tecnologias de poder do governo das matérias? Quais são as associações sociotécnicas que garantem o fluxo de bens vitais? Como artefatos – documentos, medidores, cadastros, etc. – agenciam sujeitos e criam categorias de moradores? Com variadas perspectivas teóricas, os trabalhos discutidos ao longo do curso oferecem novas possibilidades de discussão dos modos de produção das cidades, das lutas pelo direito à cidade e da reprodução de desigualdades urbanas.
